HANDICAP TOURNAMENT RULES

RULE 1: WHO MAY BOWL

Only female members of the Palm Beach County USBC, with a current USBC adult membership. Non-members of this Association may enter by paying an Associate fee of \$21.00 or (\$8.00 if they have USBC card) USBC sanction cards must be presented at check In

RULE 2: ENTERING AVERAGE

- Bowlers will use their highest 2018/2019 USBC WINTER yearbook average of 21 games or more. A)
- Bowlers with no 2018/2019 averages may use their highest January 1, 2020 average from a sanctioned league, of 21 games or more. Bowlers with none of the above may use their highest submitted 2019 summer sanctioned league average of 21 games or more. B)

- All others will bowl scratch 240. D)

RULE 2b: HANDICAP Handicap will be 90% of 240

RULE 3: 10 PIN RULE

Any bowler who has a January 01, 2020 average for 21 games or more that is 10 plns, or more higher than their entering average, must use their January 01, 2019 average.

RULE 4: VERIFICATION

Verifying the accuracy of their average shall be the bowler's responsibility per USBC Rule 319a (3)

RULE 5: REPORTING OF PRIZE WINNINGS USBC Rule 319d will be in effect with a \$1,000 minimum in a single event.

RULE 6: AVERAGE ADJUSTMENT USBC Rule 319e shall not apply.

RULE 7: NO FEES RETURNED USBC Rule 314 shall apply.

RULE 8: PARTICIPATION RULE (all events see rule 12)

Multiple participation allowed in any event depending on lane availability, multiple payouts will be allowed as per USBC Rule 315

RULE 9: TEAM EVENT

Trophies to handicap winners. In the event of a tie for the championship, multiple prizes will be awarded. Optional Scratch Entrants must bowl in handicap event. Scratch fee \$10.00 per bowler (\$9.00 prize fund \$1.00 expense fee), Optional Scratch prize fund only.

RULE 10: DOUBLES & SINGLES

(ENTRANTS MUST ENTER BOTH DOUBLES & SINGLES EVENTS) A) Trophies to handicap winners. In the event of a tie for the championship, multiple prizes will be awarded. Optional Scratch Entrants must bowl in handicap event. Scratch fee \$10.00 per bowler (\$9.00 prize fund \$1.00 expense fee), Optional Scratch prize fund only. B) NO PRACTICE BALLS BETWEEN DOUBLES & SINGLES EVENTS.

RULE 12: ALL EVENTS

First scores bowled in each event shall count towards All Events score. A)

- Trophies to handicap winners. In the event of a tie for the championship, multiple prizes will be awarded. B١
- Scratch fee \$5.00 per bowler (\$4.50 prize fund \$.50 expense fee). Optional Scratch prize fund only. C)

RULE 13: LANE BREAKDOWN OR DELAY

IN THE CASE OF A LANE BREAKDOWN OR DELAY, THERE WILL BE NO PRACTICE BALLS WHEN PLAY IS RESUMED, NO MATTER IF MOVED TO ANOTHER PAIR OR NOT. SLOW BOWLERS MAY BE MOVED AT TOURNAMENT DIRECTOR DISCRETION!

RULE 14: CHECK IN

Bowlers must check in forty five (45) minutes prior to squad time. Any substitutes must check in one hour before squad time. DEADLINE FOR ENTRIES 60 MINUTES BEFORE SQUAD, if lanes available.

RULE 15: MANAGEMENT

Authority of the Tournament Director shall be as expressed in USBC Rule 303

RULE 16: Payment MUST accompany entry. Check or money orders.

RULE 17: 1099 will be issued to bowlers with winning \$600 or more. Checks will not be issued without Social Security number.

RULE 18: TOURNAMENT MANAGEMENT RESERVES THE RIGHT TO RE-RATE ANY ENTRANT PRIOR TO BOWLING. IF THE ENTRANT REFUSES THE RE-RATE, ENTRY FEES WILL BE REFUNDED

RULE 19: LATE FEE, Entries received after February 29, 2020, requires an additional \$5.00 Per Bowler Fee

SQUAD SIZES WILL BE LIMITED ENTRIES WILL BE ASSIGNED SQUADS IN ORDER OF RECEIPT (Entries Close for Optional Scratch Event 60 minute's prior last squad)
