CHECK-IN

Check-in time is 1hour before squad time.

Walk-ins will be allowed <u>90 minutes prior to squad time</u>, based on lane availability.

Substitutions deadline is 1 hour prior to squad time.

NOTE NEW DRESS CODE

Proper attire is required! Shorts / skirts must be below fingertip length.

HANDICAP TOURNAMENT RULES

- RULE 1: THIS IS A DOUBLES TOURNAMENT OPEN TO ALL ADULT MEMBERS OF USBC.
- **RULE 2:** TEAM WILL CONSIST OF TWO ADULT BOWLERS.
- **RULE 3:** ALL BOWLERS MUST PRESENT THEIR USBC MEMBERSHIP CARD AT THE TOURNAMENT SIGN IN 30 MINUTES BEFORE SQUAD TIME. NON-SANCTIONED BOWLERS PAY A MEMBERSHIP OF \$25.00. OR ASSOCIATION MEMBER SHIP FEE OF \$12.00.
- **RULE 4: AVERAGE:** BOWLERS WILL USE THEIR HIGHEST 2020 2021 USBC WINTER YEARBOOK AVERAGE OF 21 GAMES OR MORE. IF NONE, THEY WILL USE THEIR HIGHEST 2019 2020 USBC WINTER YEARBOOK AVERAGE OF 21 GAMES OR MORE.
- IF NONE, THEY WILL USE THEIR SUMMER 2021 **SANCTIONED** LEAGUE AVERAGE OF 21 GAMES OR MORE.
- IF NONE, THEY WILL USE THEIR CURRENT **SANCTIONED** LEAGUE AVERAGE WITH PROOF OF 21 GAMES OR MORE ON A STANDING SHEET DATED AS OF NOVEMBER 12, 2021.
- IF NONE, THEY WILL BOWL SCRATCH 240. ONLY USBC SANCTIONED AVERAGES WILL BE ACCEPTED.
- ALL BOWLERS ARE RESPONSIBLE FOR VERIFYING THEIR OWN AVERAGE per USBC Rule 319a(3). RULE 319A 2 WILL NOT BE IN EFFECT.
- **RULE 5:** RE-ENTRIES ALLOWED AS PER USBC RULE 315. USBC 319D AND 319E WILL NOT BE IN EFFECT. DEADLINE FOR ENTRIES IS 60 MINUTES BEFORE SQUAD, IF LANES AVAILABLE (ONLY THREE TEAMS PER PAIR).
- RULE 6: NO FEES RETURNED. USBC RULE 314 SHALL APPLY.
- RULE 7: IN THE CASE OF A LANE BREAKDOWN OR DELAY, THERE WILL BE NO PRACTICE BALLS WHEN PLAY IS RESUMED, NO MATTER IF MOVED TO ANOTHER PAIR OR NOT. SLOW BOWLERS MAY BE MOVED AT TOURNAMENT DIRECTOR DISCRETION!
- RULE 8: USBC RULE 18: WHILE BOWLING IN USBC COMPETITION, A BOWLING BALL CANNOT BE ALTERED OR CLEANED.
- **RULE 9:** TOURNAMENT MANAGEMENT RESERVES THE RIGHT TO RE-RATE ANY ENTRANT PRIOR TO BOWLING. IF THE ENTRANT REFUSES THE RE-RATE, ENTRY FEES WILL BE REFUNDED.
