MIXED TOURNAMENT RULES

1. The tournament will consist of Mixed Team Event (2 men & 2 women) and Mixed Doubles (1 man & 1 woman) and a separate optional six game All Events for men and women.
2. All participants must have a current USBC Adult membership and be 18 year of age or older at time of competition. Captains must provide proof of membership for each bowler checking in. If current membership cannot be verified, a USBC membership card must be purchased at the tournament site.
3. All handicap event prizes will be on a handicap basis. The handicap shall be computed on an individual basis of ninety percent (90%) of the difference of an entrant's entering average and 240 scratch.
4. A scratch All Events is offered.
5. Entering Average:
 - a. 2021-22 highest USBC winter league average of 21 or more games
 - b. If NO winter average, then summer 2022 average of 21 or more games
 - c. If NO 2021-22 winter or 2022 summer average, use highest current season USBC average as of Jan. 1, 2023, of 21 or more games
 - d. Bowlers with none of the above averages must bowl scratch
6. It is each bowler's responsibility to verify the accuracy of their own average in handicap or classified tournaments, whether originally submitted by the bowlers, the team captain or others. Failure to use the correct average may disqualify the score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. Prize winnings will be based on the submitted average if it is higher than the correct average (Rule 310a). IF A BOWLER HAS BEEN RE-RATED OR REFUSED A RE-RATE IN THE PAST 10 YEARS, IT MUST BE REPORTED AT TIME OF ENTRY.
7. Reporting of previous tournament winnings will not apply (Rule 319d). The average adjustment rule will apply (Rule 319e).
8. Multiple Participation
 - a. Team Event: Bowlers must change two people each time you participate in the team event. The same two men and the same two women cannot bowl together on the same team more than once.
 - b. Doubles: Must change partners when participating more than one time.
 - c. Only exception from bowling multiple times is above rules 7(a) and 7(b). You can bowl as many times as you want as long as you change partners.
 - d. You can bowl with as many different teams as you want provided you follow rule 7(a).
 - e. All Events: ONE TIME ONLY! First time bowled in Team & Doubles will count towards all events.
9. Individuals who are members of bowling organizations identified as "professional" are eligible for participation, however not more than one professional bowler may compete on a four-member team, or Doubles team.
10. Report all substitutions to the Tournament Office at least 30 minutes prior to scheduled squad time.
11. No changes in team or doubles order of bowling will be permitted after scheduling.
12. Prize Ratio: At least 1 of 8. ALL EVENTS: 1 of 10. Prize fund returned 100%.
13. ***DRESS CODE: Bowlers must wear a half-sleeve shirt, casual slacks. Any shorts, skirts, skorts must come to the knee. During participation, bowlers are NOT permitted to wear headgear, ear buds or sweats. All clothing must be neat, clean and in good condition. Violators may NOT be allowed to participate in that event. Tournament management reserves the right to make all final decisions on dress code.***

We reserve the right to refuse entries. All entries must bowl when scheduled and no entry fees will be refunded once scheduled. Team Captains have certified on this entry that their team members agree to abide by the rules and regulations of this tournament.
