# FLORIDA STATE USBC—2023 WOMEN'S TOURNAMENT RULES Team Captain: PLEASE RETAIN FOR YOUR INFORMATION

- 1) All entrants in the FS-USBC Women's Championship Tournament must be female and have a current adult membership in their Local Association and USBC or must have a current USBC unattached membership card.
  - a) All participants must be 18 years of age or older at time of competition. Bowlers must provide proof of membership upon checking in. If current membership cannot be verified, a USBC Associate membership card must be purchased at the tournament site.
  - b) Handicapped bowlers requiring aids such as crutches, canes, wheelchairs, etc., or who are blind must report this in writing when entry is submitted so special schedule consideration can be arranged. Similar additional notice must be given if such a handicapped bowler is to be a substitute.
- All references to average shall include averages established in USBC certified leagues and/or certified youth or collegiate leagues. Entrants in the FS-USBC Women's Championship Tournament shall use their highest certified league average as of the end of the 2021 -22 winter season, provided they have 21 games or more. If no 2021-22 winter USBC certified league average has been established, an entrant shall use her highest USBC certified 2022 summer league average of 21 games or more. If no 2021-22 winter or 2022 summer USBC certified average has been established, an entrant shall use her highest current league average for 21 GAMES OR MORE as of *January 1, 2023* (bowler must provide average verification). Bowlers who do not meet these requirements shall automatically be given a 220 average in each event in which they participate.

#### USBC Rule 319 DOES APPLY. All averages are subject to further verification by the Tournament Director.

THE ENTRANT MUST USE HER HIGHEST USBC CERTIFIED LEAGUE AVERAGE OF 21 GAMES OR MORE REGARD-LESS OF WHETHER BOWLED AS A REGULAR MEMBER OR A SUBSTITUTE. The delivery used in tournament competition must be the same as that used in establishing the entering average. All winner's averages are subject to further verification by the State Assn. Mgr.

- 3) TOURNAMENT HANDICAPPED IS 100% OF 220 WITH 1 DIVISION, OPTIONAL SCRATCH EVENTS.
  - a) The State Championships are to be determined by the highest score rolled in each event, including all events.
  - b) In the event of a tie for first place in any event, co-champions will be declared. Equal awards will be given.
- 4) a) All entrants are automatically eligible for all events awards if they bowl team, doubles, and singles. To be eligible for the cash awards of the All Events an additional entry fee must accompany the entry form. Paid all events are not transferable unless the substitute replaces the original entrant in all three events and the transfer is made by the tournament director or her assistant prior to the time of the substitute's participation in any event.
- 5) Members may participate twice in the TEAM EVENT ONLY, and ONE TIME ONLY in D/S. At least two players in the lineup must be different in order to place more than once in the prize list for position standings. Scores bowled by an ineligible player will be disqualified. All Events standing will be determined by the bowler's first appearance in the team event counts toward their all events.
- 6) Members entered in the doubles event MUST ALSO ENTER SINGLES and members entered in singles MUST ALSO ENTER DOU-BLES event.
- 7) After entries have been received and dates assigned by the State Assn. Manager have been accepted, no fees shall be refunded.
- All teams, and individuals not on teams, shall be notified in writing by the State Assn. Mgr. at least three (3) weeks before the opening of the tournament of the time they are scheduled to bowl in said tournament. No changes will be made in the entrant's scheduled time except in case of an emergency and any change must be approved by the State Assn. Mgr. or duly authorized FS-USBC official.

DRESS CODE: Bowlers must wear a half-sleeve shirt, casual slacks. Any shorts, skirts, skorts must come to the knee. During participation, bowlers are NOT permitted to wear headgear, ear buds or sweats. All clothing must be neat, clean and in good condition. Violators may NOT be allowed to participate in that event. Tournament management reserves the right to make all final decisions on dress code.
