TOURNAMENT MANAGEMENT SHALL HAVE THE RIGHT TO CANCEL SQUADS IF NECESSARY AND TO REARRANGE ENTRIES WHEN TIME REQUESTED ARE NOT AVAILABLE.

HANDICAP TOURNAMENT RULES

RULE 1: WHO MAY BOWL

Only members of the Palm Beach County USBC, with a current USBC adult membership.
Non-members of this Association may enter by paying an Associate fee of \$27.00 or \$12.00 for local association.
USBC sanction card must be present at check-in.

RULE 2: ENTERING AVERAGE

- A) Bowlers will use their highest 2022/2023 USBC WINTER yearbook average of 21 games or more.
- B) Bowlers with no 2022/2023 average may use their highest January 1, 2024 average from a sanctioned league, of 21 games or more.
- C) Bowlers with none of the above may use their highest submitted 2023 summer sanctioned league average of 21 games or more.
- D) All others will bowl scratch 240.

RULE 2b: HANDICAP - Handicap will be 90% of 240.

RULE 3: 10 PIN RULE

Any bowler who has a January 1, 2024 average of 21 games or more that is 10 pins, or more higher than their entering average, must use their January 1, 2024 average.

RULE 4: VERIFICATION - Verifying the accuracy of their average shall be the bowler's responsibility per USBC Rule 319a(3).

RULE 5: P. B. A. MEMBERS

No more than 1 touring pro may bowl on a 4 person team and no more than 1 touring pro may bowl on a doubles team or scores will be disqualified.

RULE 6: REPORTING OF PRIZE WINNINGS - USBC Rule 319d will be in effect.

RULE 7: AVERAGE ADJUSTMENT - USBC Rule 319e shall not apply.

RULE 8: NO FEES RETURNED - USBC Rule 314 shall apply.

RULE 9: PARTICIPATION RULE (all events see rule 12)

Multiple participation allowed in any event depending on lane availability, multiple payouts will be allowed as per USBC Rule 315.

RULE 10: DOUBLES & SINGLES (ENTRANTS MUST BOWL BOTH SINGLES AND DOUBLES EVENTS)

In the event of a tie for the championship, multiple prizes will be awarded. Option Scratch Entrants must bowl in handicap event.
Scratch fee \$20.00 per bowler, per event (\$19.00 prize fund + \$1.00 expense fee). Optional Scratch prize fund only.
NO PRACTICE BALLS BETWEEN DOUBLES & SINGLES EVENTS.

RULE 11: ALL EVENTS

- A) First scores bowled in each event shall count towards All Events score.
- B) In the event of a tie for the championship, multiple prizes will be awarded.
- C) Scratch fee \$10.00 per bowler (\$9.50 prize fund + \$.50 expense fee). Optional Scratch prize fund only.

RULE 12: LANE BREAKDOWN OR DELAY

IN THE CASE OF A LANE BREAKDOWN OR DELAY, THERE WILL BE NO PRACTICE BALLS WHEN PLAY IS RESUMED, NO MATTER IF MOVED TO ANOTHER PAIR OR NOT. SLOW BOWLERS MAY BE MOVED AT TOURNAMENT DIRECTOR DISCRETION!

RULE 13: MANAGEMENT - Authority of the Tournament Director shall be as expressed in USBC Rule 303. Tournament management has the right to refuse any entry and settle any and all disputes.

RULE 14: Payment MUST accompany entry. Check or money orders. Fees for any returned checks will apply.

RULE 15: 1099 will be issued to bowlers winning \$600 or more. Checks will not be issued without Social Security number.

RULE 16: TOURNAMENT MANAGEMENT RESERVES THE RIGHT TO RE-RATE ANY ENTRANT PRIOR TO BOWLING.
IF THE ENTRANT REFUSES THE RE-RATE, ENTRY FEES WILL BE REFUNDED.

RULE 17: CHECK IN

Check in time is one (1) hour prior to squad time. Deadline for substitutes is one (1) hour prior to squad time.

RULE 18: WALK-INS / LATE ENTRIES

Walk-ins will be allowed 60 minutes before squad time, based on lane availability.
Entries close for Optional Scratch Events 60 minutes prior to each squad.

RULE 19: DRESS CODE -

Proper attire is required! Any shorts, skirts, skorts must come to the knee. Shirts must have sleeves. All clothing must not show offensive graphics or language and be neat, clean and in good condition. Violators may NOT be allowed to participate. Tournament Director's decisions will be final.
