TOURNAMENT RULES

1. THIS IS A DOUBLES TOURNAMENT. OPEN TO ALL ADULT SANCTIONED MEMBERS OF USBC
2. TEAM WILL CONSIST OF TWO ADULT BOWLERS
3. USBC SANCTION CARDS MUST BE PRESENTED AT CHECK IN.
NON- SANCTIONED BOWLERS MAY PAY AN ASSOCIATE MEMBERSHIP FEE OF \$27.00.
4. BOWLERS WILL USE THEIR HIGHEST 2023 - 2024 USBC WINTER YEARBOOK AVERAGE OF 21 GAMES OR MORE
IF NONE, THEY WILL USE THEIR SUMMER 2024 **SANCTIONED** LEAGUE AVERAGE OF 21 GAMES OR MORE
IF NONE, THEY WILL USE THEIR CURRENT **SANCTIONED** LEAGUE AVERAGE WITH PROOF OF 21 GAMES OR
MORE ON A STANDING SHEET DATED AS OF NOVEMBER 1, 2024.
ALL OTHERS WILL BOWL SCRATCH 240.
5. **ALL BOWLERS ARE RESPONSIBLE FOR VERIFYING HIS/HER OWN AVERAGE (USBC Rule 319A [3])** USBC
Rule 319A 2 will be not in effect
6. RE-ENTRIES ALLOWED AS PER USBC RULE 315, USBC 319D, AND 319E WILL NOT BE IN EFFECT.
DEADLINE FOR RE-ENTRIES 60 MINUTES BEFORE SQUAD, IF LANES AVAILABLE (ONLY 3 TEAMS PER PAIR)
7. NO FEES RETURNED; USBC RULE 314 SHALL APPLY.
8. **IN THE CASE OF A LANE BREAKDOWN OR DELAY, THERE WILL BE NO PRACTICE BALLS WHEN PLAY
IS RESUMED. NO MATTER IF MOVED TO ANOTHER PAIR OR NOT, SLOW BOWLERS MAY BE MOVED AT
TOURNAMENT DIRECTOR DISCRETION!**
9. **CHECK IN**
Check in time is one (1) hour prior to squad time. Deadline for substitutes is one (1) hour prior to squad time.
10. **WALK-INS / LATE ENTRIES**
WALK-INS WILL BE ALLOWED 75 MINUTES BEFORE CHECK IN BASED ON LANE AVAILABILITY.
11. **USBC Rule 18:** While bowling in USBC competition, a bowling ball cannot be altered or cleaned.
12. TOURNAMENT MANAGEMENT RESERVES THE RIGHT TO RE-RATE ANY ENTRANT PRIOR TO BOWLING.
IF THE ENTRANT REFUSES THE RE-RATE, ENTRY FEES WILL BE REFUNDED.
